Semi automatic line: automatic operation at pretreatment area (enclosed or encapsulated room), and the rest is manual operation, and the production line is basically equipped with all or some of the environmental equipment.

Manual line: all of the operation of the whole process is in manual mode, and the production line is equipped with some environmental equipment according to specific requirement.
